2013 ANNUAL SUMMARY INTERNAL AFFAIRS

COMPLAINTS:

Between January 1, 2013 and December 31, 2013 the Middletown Police Department Internal Affairs Division investigated thirteen (13) complaints of employee misconduct.

Six (6) of the cases originated from citizen complaints. Of those six (6) citizen complaints, four (4) were for Conduct Unbecoming an Officer and two (2) were for Violations of a Department Policy or Rule/Regulation. Two (2) of the complaints were substantiated.

The MPD initiated seven (7) internal investigations. Of those seven complaints two (2) were for Conduct Unbecoming an Officer, three (3) were for violations of a Department Policy/Regulation. The last two (2) investigations were mandatory Internal Affairs reviews of police pursuits. Four (4) of the complaints were sustained.
